ALL APPLICATIONS MUST BE RECEIVED BY JUNE 1st, 2018

THERE WILL BE NO ON SITE REGISTRATION. NO EXCEPTIONS !

MAFAA, Inc. reserves the right to deny or limit space to any applicant.

There is no rain date; **NO refunds are given for any reason.**

Only One (1) VEHICLE and One (1) Vendor will be allowed in each vendor space.

A single space is approximately 15' x 20'; vehicle and all materials are to be located within the assigned space. NO EXCEPTIONS!!

Vehicle height restriction in parking garage is SIX (6) feet. Vendors must supply their own tables and chairs.

NO ELECTRICITY is supplied. Vendors WHO require generators will be assigned to the back row of the garage. Generators are to be located in the rear at a location approved by the Safety Officer.

Set up time will commence at 7:00 AM. THERE WILL BE NO VENDOR SET UP AFTER 9:00 AM. NO EXCEPTIONS!

Any vendor leaving before 2:00PM may not be allowed to return next year.

The Flea Market will be open to the public from 9:00 AM to 2:00PM.

ALL SPACES ARE ASSIGNED AT THE DISCRETION OF THE FLEA MARKET COMMITTEE ON AN AVAILABILITY BASIS.

In the event your application is not accepted, your check will be returned with an explanation.

The price per space with pre-registration is \$10.00

VENDORS ARE REQUIRED TO PICK UP ALL OF THE TRASH AND EMPTY BOXES FROM THEIR SPACE

In the interest of public safety and in accordance with the wishes of our hosts.

(The Show Safety Officer has the oversight responsibility of the Flea Market)

NO DOGS, BIKES, ROLLERBLADES or SKATEBOARDS WILL BE PERMITTED ON THE PREMISES

All vendors certify by signing this application that they have a Current Massachusetts Sales and Use Tax Number.

There are no Public Phones available in the Park.

NO ALCOHOLIC BEVERAGES OR ILLEGAL SUBSTANCES are permitted. Anyone not adhering to this rule will be asked to leave immediately and will be subject to any subsequent legal action as may be appropriate.
